SECTION 4. PRIVATE LINE SERVICES

REGULATIONS

A. Provision of Facilities

1. On a given private line, terminal equipment may be provided by the customer according to the following terms:
  - (a) Equipment furnished by the customer shall be so constructed, maintained and operated as to work satisfactorily with the facilities of the Company.
  - (b) When a private line is used for data transmission, the customer shall be responsible for ordering and specifying the type of channel, the conditioning, and the data terminal subset for operation with his data processing equipment. The undertaking of the Company is to furnish the channels and the conditioning as ordered and specified by the customer.
  - (c) Local channel facilities within a city or town which are required to extend private line service from interexchange channel terminals to the customer's premises are normally furnished to the customer by a local exchange carrier. The availability and adequacy of local channel facilities will be determined by the Company, and if different local channels are required from a local exchange carrier, such facilities will be arranged for by the Company as the customer's agent for this purpose, and such charges shall be included in the customer's bill from the company on a pass-through basis.
  - (d) The company undertakes to maintain the facilities which it furnishes to the customer. The customer, or an authorized user, may not rearrange, disconnect, remove or attempt to repair or permit others to rearrange, disconnect, remove or attempt to repair facilities of the Company except upon the written consent of the company or in an emergency such as a fire or flood.
  - (e) When facilities of the customer or of others are used with or connected to facilities furnished by the Company, such use or connection is subject to the conditions set forth in 1, 2 and 3 following.

SECTION 4 PRIVATE LINE SERVICES

REGULATIONS (Continued)

A. Provision of Facilities (Continued)

1. The magnitude and the character of the voltages and currents impressed on the Company service by the equipment and wiring and the operation and maintenance of such equipment and wiring shall be such as not to interfere with any of the services offered by the Company or interfere with others. The characteristics of the apparatus shall be such that its connection to the Company service does not interfere with service over other Company circuits or channels. In cases in which additional protective equipment is required, this shall be provided by the customer or by the Company at the customer's expense. Such equipment shall be suitable to avoid hazard of damage to Company plant or of injury to Company employees or to the public because of the character or location of apparatus and of sources of power to which it is connected.
  2. The Company may, upon suitable notification to the customer, make such tests and inspections as may be necessary to determine that the above requirements are being complied with in the installation, operation, and maintenance of equipment. The Company may interrupt the service if at any time such action should become necessary in order to protect any of its services because of departure from these requirements.
  3. The Company's responsibility is limited to providing and maintaining satisfactory transmission over the facilities it furnishes. The Company reserves the right to determine routing of all interexchange channels provided on its facilities.
- (f) The installation and relocation of equipment and channels furnished by the Company will be conducted during normal business hours. If, at the customer's request, such installation and relocation is conducted before or after normal business hours, additional charges apply and will be developed on an individual case basis.

SECTION 4 PRIVATE LINE SERVICES

USE OF SERVICE

A. Resale of Private Line Service

Private Line Service is provided for use by the customer and may be resold to others, subject to applicable law. Rules, provisions, and requirements set forth also applies to customers reselling the service.

OBLIGATIONS OF THE CUSTOMER

A. The customer shall be responsible for:

1. Reimbursing the Company for any loss through theft of the equipment or apparatus on the customer's premises;
2. Providing the personnel and power required to operate Company facilities installed on the premises of the customer or authorized users;
3. Obtaining permission for Company agents or employees to enter the premises of the customer or authorized user at any reasonable hour for the purpose of installing, inspecting, repairing or, upon termination of service, removing the facilities of the Company; and for
4. Making Company facilities periodically for maintenance purposes at a time agreeable to both the Company and the customer. No allowance will be made for the period during which the service is interrupted for such purposes.

PAYMENT ARRANGEMENTS AND CREDIT ALLOWANCES

A. Minimum and Fractional Rates and Charges

The minimum period for which service is furnished is one month except when service is furnished on a specified longer term, temporary or occasional basis.

PAYMENT ARRANGEMENTS AND CREDIT ALLOWANCES

A. Minimum and Fractional Rates and Charges (Continued)

When rates are on a "monthly" basis, the minimum charge is for one month. When service does not begin on the first day of a monthly billing period, or end on the last day of a monthly billing period, the charge for the fractional party of the monthly billing period during which service is furnished will be a proportionate part of the monthly charge based on the ratio of the number of days in such beginning or concluding fractional monthly billing period to 30 days. For example, the pro rata billing for a partial monthly billing period from January 22 through January 31 is 10 thirtieths or one-third of the monthly charge. For this purpose every monthly billing period is considered to have 30 days.

B. Cancellation of Application for Service

1. When an application for service is cancelled by the customer prior to the start of installation, no charge applies.
2. When installation of facilities has been started prior to the cancellation, the charge specified in (a) or (b) following, whichever is lower, applies.
  - (a) A charge equal to the estimated costs incurred in such installation, less estimated net salvage, such estimated costs incurred to include the cost of unsalvaged engineering, supply expense, labor and supervision, and any other disbursements resulting from the installation and removal work.
  - (b) The charge for the contract period of service, including the installation charge and the full amount of termination charges applicable.
  - (c) Installation of channel facilities or equipment for a customer is considered to have started when the Company incurs any expense in connection therewith or in preparation therefor which would not otherwise have been incurred, provided the customer has advised the Company to proceed with the installation.

PAYMENT ARRANGEMENTS AND CREDIT ALLOWANCES (Continued)

C. Discontinuance of Service

When a customer requests discontinuance of private line service, recurring charges will apply for a period of ten business days after notification or until the requested discontinuance date or until the end of the original contract period, whichever is longer. The charges will continue to apply whether or not the customer continues to use the service.

D. Temporary Surrender of a Private Line Service

When, at the request of the Company, service is temporarily surrendered by the customer, credit will be allowed, the amount of which will be determined in the same manner as for an allowance for interruptions, as provided in (E) following.

E. Allowance for Interruptions

A. Credit is allowed for interruptions to station equipment for continuous periods of three days or more. The amount of credit is one-thirtieth of the monthly charge for each day or major fraction thereof of interruption.

B. No credit allowance is made for:

(a) Interruptions due to the negligence of the customer.

(b) Interruptions of service due to the failure of facilities provided by the customer.

F. Expedited Orders

The standard interval between the order date and the due date for private line services is 30 calendar days. If a customer requests a due date that is less than the standard 30-day interval, a non-recurring charge of \$500.00 per circuit will be assessed as an expedited order charge.

CONNECTIONS

A. Connections With Other Facilities

Facilities furnished by the Company may be interconnected with the facilities of others, subject to the condition that such interconnection shall not result in any harm of a technical nature to the Company's communications network.

Other facilities obtained for the customer by the Company from another company or agency are billed to the customer at the actual charges made by the other company, administration or agency for such facilities.

B. Responsibility of the Customer

The customer shall be responsible for installation, operation and maintenance of any facility, terminal equipment or communications system, provided by the customer, authorized user and any other company.

When trouble is reported to the Company by the customer or authorized user, the Company will endeavor to determine the origin of the trouble either on its own premises or on the customer's premises.

1. If the trouble is determined to be in the facilities or equipment of the Company, no charges will be applied.
2. If the trouble is determined to be caused by facilities, equipment or communications systems of the customer, the customer shall be responsible for reimbursing the Company for all costs incurred.

4.6 SPECIAL CUSTOMER ARRANGEMENTS

- A. In cases where a customer requests special arrangements which may include engineering, conditioning, installation, construction, facilities, assembly, purchase or lease of facilities, and/or other special services not offered, ACS-LD, at its option, will provide the requested services. Appropriate recurring and/or non-recurring charges will be developed accordingly.

SPECIAL CUSTOMER ARRANGEMENTS (Continued)

- B. Each Specialized Customer Arrangement (“SCA”) is an individually negotiated contract offering tailored to meet the telecommunications needs of the customer for whom the offering was designed. Each SCA contains a service, or combination of services, and includes supplemental terms and conditions, including, without limitation, prices, waivers and alternative pricing structures based upon volume, term utilization and the commitments, not otherwise provided for. An SCA may address one or more of the following customer needs related to the provision and receipt of telecommunications service(s) special provisioning flexibility; special network monitoring; special outage credit provisions; special “turnkey” operation and other specially developed features, functionality’s or undertakings. An SCA may also address, or be responsive to, special competitive conditions that exist at the time an SCA is agreed to between the Company and a customer. Unless otherwise specifically provided for, each SCA is available to all similarly situated customers for a period of six (6) months following the effective date of the provision reflecting the SCA or the SCA contract date of the initial customer for whom the SCA was designed, whichever comes first, and each SCA will be provided pursuant to identical or substantially similar terms and conditions.
